1) Policy Statement

Larrakeyah OSHC aims to attend the needs of children, parents, and Larrakeyah community in relation to hours of operation. These needs are considered when determining the hours and days of operation.

2) Background

The *Education and Care Services National Regulations* require approved providers to ensure their Services have policies and procedures in place in relation hours of operation, open and closing dates and times.

4) Principles to inform this policy.

We believe that:

- Once determined, hours of operation are rigid and must be adhered to by staff, families, and community. All service users must be familiar with the hours of operations and work within them.
- The Service will be operational during most Government school holidays and Pupil Free Days utilising the same opening and closing hours as vacation care (VAC).
- The Service opening dates and times during School Holidays and Pupil Free Days, are subject
 to the decision of the Larrakeyah Primary School Board. The Service does not operate on
 Public Holidays. All parents will be notified of days of closure via See Saw, Audiri, newsletter
 and email.

5) Rights and Responsibilities

- Families have the right to choose the hours that they utilise the service on their booked days within the hours of operation.
- No children are to be left unattended at the Service outside of these hours (see Dropping Off and Picking Up Policy). A late pickup fee, as discussed in the Fee Policy, may incur for any child that is collected after close.
- A service may be required to close due to unforeseen circumstances such as natural disaster or severe weather condition. This will only occur on advice and confirmation from the Nominated Supervision after consultation with School Management.
